- Valid trading License/ Company Registration Documents, Valid B-BBEE Certificate, Valid Tax Clearance Pin, Proof of Residence and Bank Confirmation Letter (not older than 3 months) and completed SIOC-CDT's Supplier Vetting Form.
- Certified copies of Share certificated and IDs for Directories and shareholders
