- Quarterly stipend
- Assistive devices (to enhance learning e.g. laptop with licensed software etc)
- Assistive devices for those living with disabilities (e.g. hearing aids etc)

WHO CAN APPLY?

South African Citizens who reside in or originate from SIOC-CDT's beneficiary communities and who are:

- 1. less than 35 years of age;
- 2. admitted at the relevant Public Higher Education Institution for the year preceding the academic year for application; and
- 3. in financial need to fund under/postgraduate study (preference is given to undergraduates and people living with disabilities).

- A certified copy of latest matric results including mid-year Grade 12 results, or latest university/college academic results where application is for funding 2nd year onwards;
- Proof of acceptance at a public recognised Higher Education Institution (University/ TVET/FET College);
- Certified copy of South African ID;
- Proof of residence;
- Proof of combined income of parent(s) or guardian(s) or affidavit where there is no income;
- Relevant medical note in the case of a disability.

Submit applications to the Bursary Office – the various channels for application will be listed on the application form.
