Only registered community members will be eligible to vote.

General background information

*SIOC Community Development Trust (SIOC-CDT) hereby invites communities in Ga-Segonyana to take part in the SIOC-CDT election process to **elect a candidate** to serve as a community representative and member of the board of trustees.*

SIOC-CDT was established by its Donor, **Sishen Iron Ore Company (Pty) Ltd**, for the benefit of the communities in the **Northern Cape Province and Thabazimbi (Limpopo Province)** who are impacted by its mining activities. This was to ensure that, in the long run, beneficiary communities are less dependent on the mine and can thrive beyond the life of the mining activities contributing to more reduced poverty and stronger, sustainable and empowered communities.

A Community Representative Trustee shall be elected by community members and appointed to the SIOC-CDT Board of Trustees to represent the respective beneficiary community.

How do I get involved?

STEP 1: NOMINATIONS

Self nomination or by others
 Complete a nomination form
 Obtain support, in writing or via SMS from the community members residing within the same municipal jurisdiction
 On SIOC-CDT and IEFSA websites www.sioc-cdt.co.za & www.iefsa.co.za
 Publishing of shortlisted nominees
 Candidate vetting process
 Final candidates list publishing



STEP 2: REGISTRATION

Register in person or online
 To register, you must:

- be at least 18 years old
- be in possession of proof of residence
- reside within the same municipal jurisdiction
- be in possession of a SA Identity Document/Smart Card



STEP 3: VOTING PROCESS

To participate, you should be a resident of Ga-Segonyana Local Municipality and have registered to vote
 Your name must appear on the voters roll
 Voting at designated voting stations within the Ga-Segonyana Local Municipality area



Who can be a SIOC-CDT Trustee?

The Trust Property Control Act (TPCA), 1988, as amended, stipulates that a person is disqualified from being authorized as a Trustee if he/she is, or has been:

declared unrehabilitated insolvent.
 prohibited to be a director of a company,
 declared delinquent by a court of law in terms of the relevant section of the Companies Act and Close Corporations Act.
 removed from an office of trust, on the grounds of misconduct involving dishonesty.
 convicted and imprisoned in the Republic or elsewhere, without the option of a fine, and or fined more than the prescribed amount in terms of section 69 of the Companies Act, 2008.
 an unemancipated minor or is under a similar legal disability; amongst others as per TPCA, 1988.

In addition, the SIOC-CDT Trust Deed disqualifies a person from being appointed or acting as a Trustee if such a person:

- ✗ has been sequestrated or has committed an act of insolvency.
- ✗ has been declared a prodigal.
- ✗ is over 70 years of age.
- ✗ is in the service of the state, any local municipality or municipal entity or a member of any municipal council.
- ✗ is an executive member of the board of directors of any municipal entity; or
- ✗ is an employee of any national or provincial public entity or constitutional institution within the meaning of the Public Finance Management Act, Act 1 of 1999.

And, the nominated person must:

- ✓ have a minimum of Grade 12 qualification.
- ✓ reside within the municipal jurisdiction for which you are nominated.
